- f. Community Engagement: EFIA will collaborate with EAD and local recycling centers to enhance stronger school community sustainability network.

2. Integration of Sustainability and Environmental Wellbeing

- 2.1 Curriculum Integration: Sustainability concepts will be integrated across Science, Social Science, Geography, and Moral Education by incorporating SDG related activities such as SDG 12 (Responsible Consumption) and utilizing CBSE projects like composting and plastic audits for assessment.
- 2.2 Experiential Learning: The school will have Eco Clubs or Eco Committees to lead student driven actions such as switching off lights, gardening, waste segregation, and creating water saving awareness posters.
- 2.3 Psychological Environment: The school will designate a "Wellness Corner" in the classroom that features plants, calming décor, natural light, and displays affirmations and student artwork promoting peace and environmental awareness.
- 2.4 Physical Space: The school will showcase sustainability posters and student projects on noticeboard Our school will incorporate sustainability principles in the design and construction of future projects.
- 2.5 Energy efficiency: Our school will follow Estidama principles by ensuring classroom AC is used efficiently and use LED bulbs and monitor monthly AADC bills.
- 2.6 Reuse of Books & Learning Materials: The school will implement a Book Bank at the library where students donate used textbooks and reuse art/craft materials and stationary for project work.
- 2.7 Responsible Food Consumption: Our school will promote healthy eating habits through Eat Right Get Active drive.
- 2.8 Sustainable Technology: Our school will promote digital resources over printed ones when suitable.
