**Subject:** Advisory on ensuring use of authentic NCERT Publications/ materials -reg.

Respected All Principals,

Greetings from CBSE RO & CoE, Dubai !!

At the outset, the Board conveys its sincere appreciation for the continued dedication, professionalism, and commitment demonstrated by all CBSE-affiliated schools across the UAE in upholding the highest standards of education and student welfare. Your efforts in fostering academic excellence and ensuring continuity of learning are deeply valued. It has come to the notice of this office, through credible representations, that suspected pirated / non-original / unauthorised copies of NCERT publications/ materials may be in circulation within the UAE market, with possible supply to parents and CBSE-affiliated schools. Such developments are a matter of serious concern. The use of unauthorised materials not only deviates from the prescribed curriculum framework but may also lead to academic inconsistencies, thereby adversely impacting student learning outcomes.

In this context, it is reiterated that strict adherence to authentic and officially prescribed NCERT publications/ materials is mandatory for all CBSE-affiliated schools. Ensuring the use of genuine academic resources is essential for maintaining curriculum integrity, academic uniformity, and the credibility of the CBSE system.

Accordingly, all schools are hereby advised to:

- Exercise due diligence and caution while procuring NCERT books and related materials.
- Ensure that only authentic, original, and officially prescribed editions of NCERT publications are used within the school.
- Put in place robust internal verification mechanisms to check the authenticity and source of all academic materials.
- Sensitise parents, in an appropriate and supportive manner, about the importance of purchasing authorised NCERT books/ material to safeguard the academic interests of their wards.
