## SCHOOL-PARENT AGREEMENT

#### I understand and agree to abide by the following:

- Policies and procedures pertaining to students for enrolment, attendance, behavior, assessments, transportation, uniforms, school breaks, student and parent code of conduct, cultural considerations, school bags, and other required rules and regulations are provided by the School in line with ADEK guidelines. The school deserves the right to timely revise and update them by making any modifications or additions. Failure to adhere to the guidelines outlined in the relevant policies by my ward may result in disciplinary action.
- My ward is obligated to consistently attend class and arrive at school on time to participate in the morning assembly.
- The school will handle persistent tardiness seriously, and the entryway will be secured at 7.50 am. Latecomers will only
  be permitted into the classroom with the authorization of the principal.
- The school mandates students to attend term-end examinations with an average attendance of 98%-100%.
- It is compulsory to wear the proper School uniform and ID card at all times while in school. Boys must have neatly
  trimmed and short hair with hair should not fall on the forehead. Girls must be with either short hair or double plaits with
  black ribbon for long hair Disciplinary measures will be initiated for the breach of the Uniform Policy.
- The School Bag Policy stipulates the size of the bag and limits its weight shall not exceed 5-10% of the child's body
  weight. Sharp objects, cell phones, firearms, and toys that interfere with studying are all forbidden in schools, and any
  infraction is subject to disciplinary action and understand that my ward will bring the devices/lunch box in a separate
  carrier to reduce bag weight.
- The dress code for parents' and students' visits to the school will adhere to the Cultural Consideration Policy in line with ADEK norms, and it is strictly forbidden to break it.
- Unauthorised departure from the school premises during class hours will not be accepted. At the parent's request or to
  fulfill any formal requirement backed by documents or medical necessity, permission will be granted.
- It is mandatory to attend the Internal and External examinations administered by the school.
- Promotions are determined on the average of the exams conducted throughout the year, as per the Promotion Policy.
- Engaging in any sort of malpractice in Examinations will result in severe disciplinary actions as per the Examination /School students' Behaviour Policy.
- Maintain Academic honesty and avoid plagiarism. Follow the Federal Decree-Law No. (38) of 2021 on Copyrights and Related Rights and the ADEK terms and conditions, copyright policy, and data privacy policy with regard to the collection, use, and disclosure of information and be responsible while using copyrighted material and digital tools (e.g., artificial intelligence).
- Visiting any abandoned or off-limits locations on or off the school site is strictly forbidden. If students engage in inappropriate behavior or engage in disciplinary activities, whether or not they are wearing school uniforms, ADEK regulations will be sternly enforced.
- It is obligatory to be personally present or arrange for an authorized person (approved by the School) to pick up point /
  drop off point to accompany/receive my child (applicable for children below 11 years only).
- The bus escorts' instructions must be respected and fulfilled. Parents or pupils should never impede the proper
  operation of school buses. In case of any complaints, they should be officially addressed to the School Transport
  Department for resolution. Observe the school's transport regulations. The school will take remedial action in
  accordance with the school bus transportation policy for careless
  - behavior, including eating, pacing, and damaging the seat or other components of the bus. A fine will also be levied for any or such nature of damages.
- The School will not be held accountable once I / the authorized school-parent approved person take up my ward from the pickup and drop-off collection point designated by the School Transport
- I am aware that the tuition must be paid in three terms or annually, and the bus fee must be paid in one or two equal
  installments. I will ensure that the timely payments of applicable fees in respect of my ward/s are paid on scheduled due
  dates before the deadline that corresponds with the notification received from the school. If I prefer to pay the fee by
  cheque, I'll make sure to have sufficient funds in my bank account.
- I will ensure that my ward will not violate the safety regulations or expose himself/herself or others at risk while riding the bus. He / She will remain seated with a fastened seat belt throughout the journey. He / She will not misbehave, cause trouble, or get engaged in any inappropriate or arrogant behavior in the school bus.
- I am aware that the school can prevent my ward from using the School transport services (i) If he/she continues violating the safety regulations or exposes himself /herself or others to danger during the trip and after being given the first

- I ensure that my child adheres to safety guidelines issued by the school during any play activities. The school has no

- Students should not engage in behavior that causes physical, verbal, or psychological harm to schoolmates. Involvement in any unfavourable or in-disciplinary actions, both within and outside of school, will be solely the responsibility of the student and the parent. Parents must visit/ attend the school at all Open House Meetings online and offline to discuss the academic performance and progress of their wards. Parents should collaborate with class or subject teachers and regularly check and respond to the school correspondence.
- Effective and timely collaboration is a primary necessity for the Academic success of the students, hence, ensuring
  parental involvement for student learning and Holistic growth.
- It is essential to maintain current knowledge and understanding of the school policies, rules, standards, and regulations of the school, including amendments.
- It is mandatory to adhere to school policies and guidelines, respect the school staff, communicate effectively, and follow the authorized implementation procedures for resolving concerns
- It is restricted to use personal devices on the school network and school premises unless authorized, and during extracurricular activities that take place outside school (e.g., field trips).
- It is restricted to the use of Virtual Private Networks (VPNs) by students on school premises or through school networks unless explicitly authorized for specific educational or administrative purposes
- It is strongly cautioned towards using WhatsApp groups for any purpose-related chatter:
  - Communicate complaints
  - Communicate about personal concerns.
  - Focus your attention on questioning a different child's conduct
  - Discuss the staff's and teachers' work.
  - Initiate and follow up debates or postings about politics or religion
- When the School provides support and guidance to parents who are seeking to switch curricula, I am aware of the
  impact of changing curricula and the potential challenges that may arise from a break in the continuity and progression
  of learning as well as the UAE equivalency requirements and require their signing of an undertaking should they
  choose not to seek equivalency
- I am aware of the inclusive admissions processes (if applicable), requests for clinical assessment reports, inabilities to accommodate students, provide regular progress updates on their child's learning, and engage parents in decision-making related to any modified curriculum pathways that may affect equivalency requirements. I know that the additional fees for support that is not part of the school's standard inclusive provision, referrals for specialized placement, and/or requirements for Individual Assistants or a dedicated Inclusion Assistant.
