ALAFCA -AL AMEER FOOD CARNIVAL – Rules and Regulations

Dear Participants,

We are delighted to welcome you to the ALAFCA- ALAMEER FOOD CARNIVAL

To ensure a seamless and enjoyable experience for everyone, all participants are required to comply with the following rules and guidelines for stall operations:

1. Single Category Stalls

Each stall must operate within a single category. Selling items across multiple categories is strictly prohibited. For instance, a stall selling Food items cannot simultaneously sell accessories, goods or other unrelated items. We have clearly mentioned different categories in the circular at the time of registration.

2. Provided Facilities and Additional Requirements

- Each stall will be provided with a standard 2-meter table and chairs.
- Should additional furniture or equipment be necessary, participants are responsible for arranging and bringing these items themselves.

3. Team Composition and Supervision

- A maximum of **three members** is permitted to manage a stall at a time
- For minors and participants of exhibition or cultural events, one parent must accompany them and will be counted as part of the three-member limit.

4. Restrictions on Cooking and Use of Equipment

- Live cooking is strictly prohibited.
- Approved equipment includes toasters, microwaves, and air fryers. Induction stoves are not permitted.
- A comprehensive list of equipment must be submitted for approval by the coordinators prior to the event. Equipment not listed and approved will not be allowed on-site.
- Participants requiring power for equipment must bring their own extension cords, as the availability of power outlets is limited.

5. Hygiene and Sanitation

To ensure hygiene and sanitation standards, all members are required to wear apron with gloves and hair cap.

- All stalls are required to keep their serving spaces clean and hygienic. Please keep all additional items such as sanitizer and tissues to ensure cleanliness.
- All food items should be covered in display trays or plastic wraps. No food items are to kept open without proper cover.



6. Designated Dining Area

To maintain smooth operations and reduce congestion, all food purchases must be consumed in the designated dining hall. Stalls are solely for selling and serving food items.

7. Dual Event Participation

• Participants involved in both **ALAFCA** and **ALAMEX** or FANTAZIA must seek approval from the respective event coordinators to continue their involvement in other events.

8. Stall Essentials and Promotions



Stalls are required to bring their own tableware, disposable cutlery, towels, tissue boxes, menus, banners, shopping bags (for accessory stalls), game items and decor items.

 Participants are encouraged to promote their stalls through social media, flyers, and banners to attract customers. Aggressive marketing is permitted and encouraged to boost visibility.

9. Compliance with Rules

• Non-compliance with any of the rules outlined above will result in the immediate revocation of the stall by the in-charge team. Decisions made in this regard will be final and are not subject to further explanation.

Your adherence to these guidelines is essential to the success of the event. Thank you for your cooperation and commitment to ensuring a vibrant and well-organized ALAFCA Food Carnival.
