- Empower students to be insightful about the information pertaining different career options, career goals and other aspects for leading a meaningful professional career.
- To assist students to understand their own career and academic aspirations.
- Providing training for students to know self-awareness and self-direction which is vital in career planning.
- Help them understand their own strengths and limitations and enable students to develop own ability to solve problems and take concrete career decisions.
- Helping students in adapting and managing the transition of life from school to career work life.
- Train students effectively to utilize the acquired theoretical and practical knowledge in their professional career life.

WHAT IS A CAREER AND UNIVERSITY (CU) GUIDANCE PROGRAM?

A CU Guidance Program can be defined as a comprehensive, grade-relevant developmental program designed to help students make and implement informed educational and occupational choices. The program includes a five-step development approach:



Implementation of the activities:

- Preparing application forms, and recommendation letters to universities for student's higher education.
- In-house training on career paths, disseminating information about various subject scopes and fields students can explore in their career life.
- Advocacy and networking initiatives with external agencies to provide placement opportunities to avail good practical exposure in their interest career field.
- Encouraging students to participate in virtual webinars and workshops organized by ADEK, private institutions and external agencies on writing applications, university scholarship programmes.
- Liaise with external agencies for conducting personality assessments, aptitude tests pertaining to career path.
- Advocacy and network with external agencies to provide opportunities for summer placements in the respective institutions.
- Arranging orientation/ observational training visits for students on their interested career institutions.
