Please be informed that your ward has to be registered for **Grade IX CBSE Examination 2021-22**. You are requested to fill the following details and submit the hard copy to the School office (Admission Assistant) **on or before 10th October 2021** during the school working hours. The details which you are furnishing will be registered to the CBSE. No changes will be entertained after providing the data.

The following documents have to be submitted:

1. The copy of relevant documents to support name and other data (Birth certificate of the student, Passport copy of the student, father & mother – front & back).
2. **Recent highly contrast passport size photograph, preferably black & white**, of the students which **clearly indicates the name of the student** printed on the front side **along with the date of taking the photograph**. Photograph should be taken in proper school uniform, ID Card and hairstyle (photograph should have been taken on or after 1st April 2021 of the academic session) **[2 copies to be submitted]**
3. **Recent highly contrast passport size coloured photograph** of the students which **clearly indicates the name of the student** printed on the front side. Photograph should be taken in proper school uniform, ID Card and hairstyle (photograph should have been taken on or after 1st April 2021 of the academic session). The Head should be positioned directly facing camera, centered and compose 80% of image. Photo should capture from slightly above top of hair to middle of chest, have a natural expression. Eyes must be open and looking at the camera. Glasses must not be tinted unless worn daily for medical purposes. **[2 copies to be submitted]**
4. **It is mandatory to attend all the three Periodic tests and Term 1 & Term 2 Board Examination and the attendance of your ward should be 75%.**
5. **Aadhar No. field is mandatory.** If Aadhar No. is not available **Passport No.** can be provided. If **Passport No.** is not available, **Social Security Number/ID Number** issued by the Foreign Country may be mentioned.

Please fill the details in CAPITAL LETTERS. It is mandatory to fill all the data.
