## **INTRODUCTION**

Immediate notification of all online accidents, incidents and near misses are required as per the school regulations to ensure that any safety or risk issues are addressed.

This guidance has been prepared by HABITAT SCHOOL AL TALLAH that provides a clear guidance on Incident Reporting system in order to learn lessons from adverse events, incidents and near misses. The school aims to ensure the reporting of any event which has potential for unintended or unexpected Cyber safety or psychological problems of Students and E learning Platform. When things do go wrong it is now widely accepted that the response should not be one of blame and retribution, but one of learning, with an overarching aim to minimize risk.

## **PURPOSE**

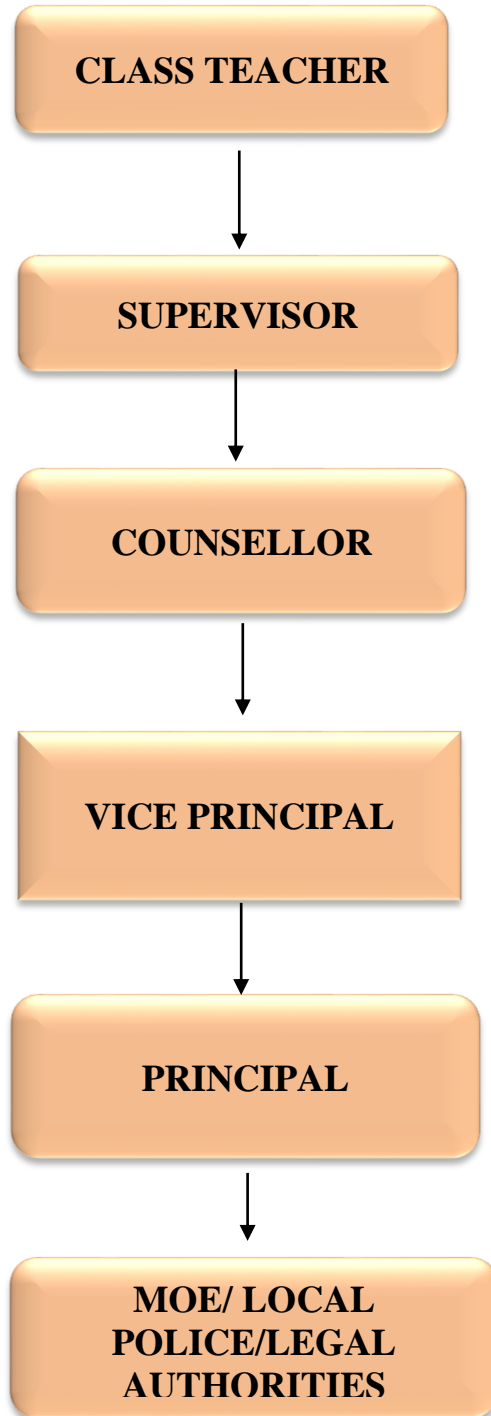
- To define the classification of incidents and establish a common approach for reporting any accident incident for meeting the following objectives:
- Ensure all critical incidents are investigated.
- Identify the root causes of all incidents and develop the necessary corrective or preventive actions and measures to prevent recurrence.

## **Procedures:**

In case of any online incident the following reporting structure is followed but depending on the seriousness of the incident it can be directly reported to the School Principal / OSL without following the protocols.

When completing accident reports it's ensured that the information is an accurate account of the accident. It is important that those filling in the form do not speculate or provide unnecessary information. The same applies to any related correspondence such as witness statements, emails, meeting notes etc.as it will be used as evidence in any subsequent court case where it will be ensured that all the records are purely factual.
